On December 3rd, 2022, at approximately 1519 hours, the Martin County Sheriff's Office received several in reference to a shooting that occurred at 2929 S.E. Ocean Blvd, Apt 135-4 Stuart, Florida (Cedar Point Apartments.) One of the Hugh Hootman shot the was ' 1. She advised neighbors downstairs. was currently with her and took the gun apart and stated her then it was left outside. stated there was an ongoing dispute over the washer and dryer.

Dispatcher the victims were named Henry and Ginger. Multiple Martin County then told Deputies and Stuart Police Department Officers responded and observed two deceased individuals on the walkway adjacent to apartment number 4. The suspect, Hugh Hootman, was taken into custody without incident. I responded to the above location, upon arrival, I met with Lieutenant Schimelfanick who provided the following information.

Lieutenant Schimelfanick stated he was first on scene to the incident. When he arrived, he observed two subjects, male and female, lying in the ground near the entrance to several apartments. It was quickly determined both subjects were deceased from apparent gunshot wounds. Lieutenant Schimelfanick stated other members from the Sheriff's Office arrived and took positions around the apartment complex. A short time later the suspect (defendant) Hugh Duane Hootman was taken into custody.

I conducted a brief walk through of the scene and observed two elderly subjects, one male and female. The deceased female was lying on her right side. There was blood on the torso area of her shirt; the male subject was laying on his back with blood coming from his head and torso area. There were multiple bullet casings laying next to each of the decedents. The scene was secured until Martin County Sheriff's Office Crime Scene arrived.

I responded to the Martin County Sheriff's Office where Hugh Hootman was transported for questioning. Detective Carolan and I then conducted an interview with Hugh. Detective Carolan read Hugh Miranda Rights.

Hugh Hootman stated he understood. Hugh Hootman went on to say several days ago the victim, Henry Wallace, came to his (Hootman's) apartment and confronted . Henry Wallace was upset that the Hugh's left the community laundry room door open. Hugh Hootman stated Henry Wallace cussed and yelled at which in return made her very upset.

Hugh Hootman stated today, December 3rd, he went downstairs to check his mail at the community mailbox. Hugh Hootman stated Henry Wallace was also at the mailbox. Hugh Hootman stated he told Henry Wallace he needed to apologize to for cussing and yelling at her. Hugh Hootman stated Henry Wallace ignored him and attempted to push past Hugh Hootman to walk away. Hugh Hootman stated, "I lost my temper". Hugh Hootman stated he retrieved his 9mm pistol from his right pocket and charged a round into the chamber. Hugh Hootman stated he then pointed the weapon at Henry Wallace with both hands and shot Henry Wallace two times in the chest area. Hugh Hootman demonstrated this to me, and he was approximately 3-4 feet away from Henry Wallace when the shots were fired. Hugh Hootman stated Henry Wallace collapsed to the ground.

Hugh Hootman then stated Ginger Wallace (second victim) who is Henry Wallace's wife, exited their apartment and started yelling and screaming. Hugh Hootman could not recall what Ginger Wallace was yelling. Hugh Hootman stated Ginger Wallace did not advance towards him (Hugh Hootman). Ginger Wallace was just standing close to her husband's body when Hugh Hootman raised his pistol again with both hands and fired two more shots at Ginger Wallace. Hugh Hootman stated Ginger Wallace also collapsed after the shots were fired. Hugh Hootman also demonstrated this, and he was approximately 5-6 feet away from Ginger Wallace when he fired his weapon.

Hugh Hootman stated he then walked back upstairs to his apartment where I was located and set the pistol on a wooden stand in the living room. Hugh Hootman stated to I "call the police, I just shot Henry and Ginger". Hugh Hootman stated there was no more conversation between him and until law enforcement arrived.

Further questioning post-Miranda revealed Hugh Hootman has a CCW and he normally carries his 9mm pistol in his pocket for protection. Hugh Hootman also confirmed he never keeps a round in the chamber of the firearm. Hugh Hootman stated he was, "so sorry, wish I could take it back". Hugh Hootman also wrote an apology letter which is attached to this Affidavit. Hugh Hootman kept reiterating how upset he was that Henry Wallace had yelled at and would not apologize.

Based on the above investigation, Hugh Hootman violated Florida State Statue 782.04 First Degree Murder, by unlawfully killing Henry Wallace and Ginger Wallace.
